## **UPDATES AT THE LENT TOWN HALL**

For the past 18 months, cosmetic renovations have been taking place to help with the acoustics in the Hall, updates in the serving kitchen, along with reviewing plans to upgrade the restrooms to make them ADA compliant. The office has had new carpet and artwork added with plans on painting the ceiling.

We have lighting in the parking area at night along with lighting of our new US Flag. The Hall has seen some spectacular weddings and events, with bookings into 2020. There are a few select weekend dates open for 2018.

Reasonable rental costs are available with a full serving kitchen for your caterer and guests. Although we do not offer the Hall free for events, we have carefully accessed the price for nonprofit events.

Lent Township has been granted funds to host Pickle Ball at the Hall with all the equipment available to players. This is currently in the process and game times will be posted.

## **ROAD NEWS!**

At the Annual Meeting the residents made it clear they are ready for some changes. The Township Road Committee presented an option to blacktop and double chip seal existing gravel roads. They explained they are working on a 25 year rotational road plan. In doing so, it is evident that continuing to convert roads from gravel to blacktop or double chip would be a long term cost savings to the residents. Many residents had voiced concern about the dust and mess produced from the gravel roads. Updates will be posted to the website or you are welcome to attend the Road Committee meetings.

#### **ASSESSMENT NOTICE**

Important Information Regarding Assessment and Classification of Property. This may affect your 2019 property taxes.

NOTICE IS HEREBY GIVEN, That the Board of Appeal and Equalization for the Township of Lent, CHISAGO County, Minnesota, will meet at the Office of the Clerk in said Township At 6:00 o'clock PM., on Thursday the 26th day of April, 2018 for the purpose of reviewing and correcting the assessment of said Township of Lent for the year 2018.

The purpose of this meeting is to determine whether taxable property in the jurisdiction has been properly valued and classified by the assessor, and to determine whether corrections need to be made.

All persons considering themselves aggrieved by said assessment, or who wish to complain that the property of another is assessed too low, are hereby notified to appear at said meeting, and show cause of having such assessment corrected. No complaint that another person is assessed too low will be acted upon until the person so assessed or his agent, shall have been notified of such complaint.

If you believe the value or classification of your property is incorrect, please contact your assessor's office to discuss your concerns. If you are still not satisfied with the valuation or classification after discussing it with your assessor, you may appear before the local board of appeal and equalization. The board shall review the valuation, classification, or both if necessary, and shall correct it as needed. Generally, an appearance before your local board of appeal and equalization is required by law before an appeal can be taken to the county board of appeal and equalization.
