

## Lent Township Road Committee Meeting Minutes February 6, 2017 11:02 am Minutes

## 1 year road projects include:

- Gravel Elk Lane Class 1
- Gravel Elk Court Class 1 The 2 roads will be \$16k
- Fix Falcon Ave culverts Concrete \$10k
- Blacktop Iris Ave \$90k per mile
- Emily Lane and Emily Court gravel and chloride \$32k
- 320th Street to Floral Avenue gravel
- Erie Lane South gravel
- 352nd Street gravel The 3 roads will be \$20k
- Jewel Lane/Jewel Court gravel Class 1 and Chloride it \$16k
- Analyze Ivywood Trail to see how much gravel is there \$64k to gravel
  The counter will be put down for 2 weeks on north and 2 weeks on south.

# Plan B: if the gravel is good on Ivywood Trail then it needs a base coat

#### 2-3 year road projects

- All bituminous roads will need maintenance crack sealing
- Hemingway/350<sup>th</sup>/Gopher gravel **Plan B**
- Kale Ave 344<sup>th</sup> to the end **Plan B**
- 347<sup>th</sup> Street/Ivan Avenue/345<sup>th</sup> Street wear coat
- 320<sup>th</sup> Street from Falcon to Lions Street wear coat
- Enchantment Lane wear coat is in bad shape \$90k to add another layer
- 315<sup>th</sup> Street/Frontier Avenue/320<sup>th</sup> Street paving
- Elk Lane/Elk Court/321<sup>st</sup> Street paving

## 5-10 year road projects

- Elmo Avenue/Elmcrest/340<sup>th</sup> paving
- 311<sup>th</sup> Street/Echo Lane/Echo Court paving
- Falcon Avenue south of Stacy Trail-rebuild/repave/bridge repair
